### **How Do I Join Fresno Rotary?**

Fresno Rotary welcomes membership to adults who demonstrate good character, integrity, and leadership. They must possess a good reputation within their business, profession, and community and be willing to serve in their community and/or around the world.

Completed applications are submitted to the Rotary office, located inside the Fresno Chamber of Commerce at 2331 Fresno St. Fresno, CA 93721. The Board of Directors reviews all applications and makes a determination on the candidate. After approval, you and your sponsor will be contacted to arrange a New Member orientation and a date to be introduced to the members at a regular club meeting.

### **What Does Fresno Rotary Cost?**

Age 40 and over is \$160/month  
Age 39 and under is \$130/month  
Clergy is \$138/month

### **\$200 initiation fee must accompany application (unless under age 40, or a member of the clergy, or a former Fresno Rotary Club Member)**

Membership Include: Weekly lunches, dues, donations to the Fresno Rotary Foundation and the Rotary Foundation, Rotary Club of Fresno projects, and one annual directory.

Elective Costs can Include: Guest lunches, Registered events, Sports Day (Golf and other activities), raffles, etc.
